ATLANTA HIGHLIGHTS

> Atlanta, GA MSA/Center of the Southeast – College Park is part of the Atlanta, GA MSA and benefits from its location inside the perimeter of the city and its commerce, amenities, entertainment, and culture. Metro Atlanta is the population, employment, and transportation center of the Southeast, and the ninth largest metro area in the United States. Atlanta's exceptional qualities of life, low cost of living, diverse job opportunities, education infrastructure and cultural amenities have attracted the largest in-migration of new residents in the U.S. during the last decade.

> Fast Growing Population – The Atlanta MSA is one of the fastest-growing areas in the United States. The current population is estimated at nearly 6 million residents, which is a 60% increase from 1990. Total households increased from 1.1 million in 1990 to 1.94 million by 2009 and were projected to increase to 2.15 million by the end of 2014

> Popular International Destination – In recent years, the strong business climate and ease of access have drawn a tremendous amount of international interest and investment to Atlanta. More than 400 international flights leave from Atlanta's Hartsfield-Jackson International Airport each week, making the city increasingly accessible to foreign investors. There are more than 1,200 foreign-owned facilities in Atlanta that employ close to 81,000 employees. The countries with the largest presence in Atlanta are Japan, Germany, The United Kingdom, France, and Canada.

> Employment Hub – Atlanta is the economic hub of the Southeast. Many national surveys continue to rank Atlanta among the nation's best cities for business and entrepreneurial activity. A very diverse economy, the city serves as the headquarters for 13 Fortune 500 companies which places it fourth behind New York (42), Houston (24), and Dallas (14). Notable companies include Coca-Cola, Cox Enterprises, Delta, The Home Depot, and SunTrust. The area is also home to thousands of government and military-related jobs including the CDC, Fort Gillem / Fort McPherson, and Lockheed Martin. According to Property and Portfolio Research, Atlanta's projected employment growth rate for the next five (5) years is 3.5% which is 66% higher than the projected U.S. growth rate of 2.1%. In addition, the projected unemployment rate over the next five (5) years for the metro area is well below the U.S. average at 6.5% versus 7.2%.

> Corporate Relocation and Expansions – Atlanta continues to benefit from corporate relocations and expansions due to its strategic East Coast location, access to transportation, educated workforce, and quality of life. Noteworthy firms that have relocated their corporate headquarters recently include NCR, First Data, Novelis, Sony Ericsson, and Efinity Corp. In addition, Verizon and GE Energy plan to expand operation bringing up to 1,000 new jobs to the metropolitan area. For this reason, the city is primed to maintain its high growth while attracting new talent.



ATLANTA HIGHLIGHTS

> Transportation & Infrastructure/Air Transportation-the World's Busiest Airport – The world's busiest airport by passenger traffic since 1998, and by number of landings and take-offs since 2005, Hartsfield–Jackson held its ranking as the world's busiest airport in 2012- both in passengers and number of flights, by accommodating 95 million passengers (more than 260,000 passengers daily) and 950,119 flights. Many of the nearly one million flights are domestic flights from within the United States, where Atlanta serves as a focus city for Southwest Airlines and the primary hub for Delta Airlines. At nearly 1,000 flights a day, the Delta hub is the world's largest airline hub. The airport also has international service to North America, South America, Central America, Europe, Asia, and Africa.

> Atlanta Interstate Network - Interstate 85, 75, 20, and 285



> Railway Service - Georgia boasts one of the most extensive Freight Rail systems in the U.S., with 5,000 miles of track that run through most of the state's 159 counties. The primary Class I railroads serving Atlanta include CSX and Norfolk Southern. Intercity Passenger Rail Service in Georgia is provided by the National Railroad Passenger Corporation, known commonly as "AMTRAK."


> MARTA/Metropolitan Atlanta Rapid Transit Authority – MARTA is the principal rapid-transit system in the Atlanta metropolitan area. It is the eighth-largest rapid transit system in the United States by ridership. Formed in 1971 as strictly a bus system, MARTA operates a network of bus routes linked to a rapid transit system consisting of 48 miles of rail track with 38 train stations.
